Sub: Joint Procedural Order for fitment, fitness, inspection and Training for Loco Kavach equipment on IR.

Ref: CLW Purchase order for 10000 nos Kavach Loco equipment

Approval of vendors for Kavach Version 4.0 has commenced on Indian Railways. Fitment of Kavach on locomotives at various sheds across IR has also begun. In order to streamline the procedure for fitment, fitness, inspection and training for Loco Kavach equipment on IR in various sheds, the following procedure is to be adopted:

1. Fitment, Inspection, Testing, and Approval of Loco Kavach under the CLW Purchase Order:

The following procedure shall be followed:

I. Loco Kavach material inspected by RDSO will be installed on locomotives as per the distribution issued by CLW to various loco sheds.

After the Kavach fitment in locomotives and joint testing with the OEM as per the pre-commissioning checklist (PCCL), the PCCL shall be jointly signed by the nominated SSE/JE (Elect.) of the loco shed and the OEM representative.

III. Scenario-Testing of Kavach-fitted locomotives shall also be carried out on the test track available in the loco shed as per the simulation test protocol.

- IV. Once the Loco Kavach is fully tested in the shed, it shall be so mentioned in the Engine fitness certificate by incorporating an item for Kavach fitness.
- V. The installation of the test track in the loco sheds is to be supervised by SSE/S&T to be nominated by Sr DSTE of the division where the shed is located.

2. Training of Shed Officials:

- IRISET has been instructed to organize training courses in consultation with the Centre for Excellence (CoE) for training of shed staff in effectively carrying out various tests required to be done post installation on the Locomotive.
- All pneumatic / testing supervisors of the shed, loco shed officers involved in the Loco Kavach fitment/testing and operation officers (electrical & mechanical from division), shall be nominated for this training as per the schedule to be planned by Zonal Railways (PCEEs).
- III. The training will cover understanding of the pre-commissioning checklist, Loco Kavach fitment and troubleshooting techniques for Kavach systems.

3. Loco Kavach fitness:

The fitness of the Loco Kavach equipment will be valid for a period matching the schedule inspection of the locomotive. However, the fitness will not automatically expire in case of overdue locos except in case of equipment failure.
