IRISSET issued notification on 16.02.2023 seeking applications from JEs/SSEs (Signal & Telecom) to fill up 20 posts of Instructors (13 in Signal stream and 7 in Telecom stream) in IRISSET. The purpose of this notification is to fill up the vacant posts of Instructors and to bring in fresh faces in faculty positions replacing the Instructors who have completed their tenure. The requirement of Instructors is predominant at this point of time to handle increased workload to impart training on latest technologies like Kavach, MSDAC, EI, IP-MPLS, LTE etc.

Sub : Relieving staff for serving in IRISSET.

As per extant instructions as contained in Para 244 of Indian Railway Establishment Code (IREC), Volume-I, Fifth Edition 1985, Third Reprint Edition 2008, reads with Para 1401 of Indian Railway Establishment Manual Volume-I (Revised Edition 1989), First Reprint Edition 2009, permission to a Railway servant to submit an application in response to post advertised outside the Parent Railways shall not ordinarily be refused unless the head of the office or department in which he is employed considers that the grant of permission would not be consistent with the interest of the public service. The competent authority should interpret the term "public interest" strictly subject to the condition that forwarding of application should be the rule rather than the exception. The cadre controlling authorities would consider each case only from the point of view whether the Railway servant could be spared or not, no other general considerations should be applied in taking a decision in the case.

2. Indian Railways Institute of Signal Engineering and Telecommunications (IRISSET), Secunderabad, one of the Training Institutes of the Railways, have expressed difficulties in achieving their target due to shortage of S&T Instructors and because of the fact that S&T Supervisors selected to work against the Ex-cadre posts of Instructors at IRISSET are not being relieved by their respective parent railways and have also requested that the Zonal Railways may be directed to forward the applications of willing S&T Supervisors to IRISSET for joining the posts whenever notifications are issued.

3. In the light of the above, the matter has been considered and it is advised that the concerned Zonal Railways and Production Units should relieve S&T Supervisors who have been selected for IRISSET. Moreover, applications of the willing S&T Supervisors to be posted at IRISSET in case of their selection may also be forwarded without delay as prescribed in the above mentioned procedure.
